Session A: A National Survey of Acquisitions

For archives with limited budgets, the task of acquiring and preserving digital records over the long term is a daunting one. In the context of the InterPARES 3 Project and as one of its 'general studies', the authors have conducted a survey asking archivists working in small and medium-sized archives nine questions about their preparedness, strategies, and thoughts on the long term preservation of digital records in their areas of acquisition. The proposed paper will summarize and analyse the final results of the survey, and present the conclusions of the authors about the current and future state of the digital preparedness of small and medium sized archival organizations and programs across Canada.

Session C: Cooperative Acquisition Strategies

The purpose of this session will be to start a conversation amongst B.C. archivists about cooperative acquisition strategies. A cooperative acquisition strategy is when a group of institutions in a specific region agree to a set of principles and practices for making acquisitions, ensuring clarity across institutions where acquisitions and deaccessioning are concerned. Such strategies have been used to decrease feelings of competition between institutions (as was the case with GARM). The discussion will start with a 15 minute introduction to the concept of cooperative acquisition strategies and their

application elsewhere, after which participants will be encouraged in small groups to discuss and debate the applicability of a cooperative acquisition strategy to British Columbia. The last part of the session will be devoted to discussion as a group.

Session E1: Managing Electronic Legal Records in Islamic Syariah Courts: E-Syariah System

Managing electronic records in their original form is now a well-accepted practice as organizations move from manual to automation. This study seeks to find out whether the Department of Syariah Judiciary Malaysia includes records management elements, particularly for long-term preservation of records, in its Electronic Syariah (E-Syariah) system. The development approach of E-Syariah has only exclusively considered the element of information technology, i.e. providing speedy, efficient and effective access and retrieval of information. Records management elements, particularly appraisal and long-term preservation are not considered. Thus, the framework to be developed by this study will take into consideration the records management elements namely the preservation function.

Session E2: Network of Structures and People: Developing and Implementing a Recordkeeping System

This paper highlights the need to consider organizational cultural issues that can exist amongst different organizations and even within the same organization. Based on research conducted in the context of the InterPARES project, it will examine the varying worldviews of different groups of stakeholders - archivists, records managers, record creators and IT and the organizational dynamics and tensions involved when different subcultures interact with one another. The paper draws on aspects from the management science literature to examine the interplay amongst people, structures, records management tools and technologies. It provides an insight on what facilitates and constraints human behaviour in terms of the records creation process and its implications for archivists keen to institute controls on the management and preservation of records.
